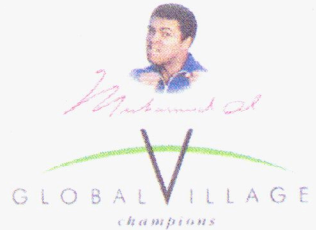

Hi Nageh,

I am writing to you in response to your request for clarification as to the codes and dates that appear on our product labels.

You will find three sets of numbers on the label and here is what each of those means:

**333160** This is our SKU number or internal product code. You can find this number on all invoices and correspondence. It refers to the product and flavour. In this case it would be VitaPro TVP (textured vegetable protein) BEEF (artificial) flavour.

**501471** This number is a VitaPro internal code which we use to describe the actual label and inventory. Purely an internal VitaPro code.

**0701020056** This code is the production date and time code. It is year/month/day/batch. In this case the product was produced 07 (2007) 01 (January) 02 (second day) and 0056 (this was the 56<sup>th</sup> production batch of the day)

As an example: If the product would have been produced April 12, 2007, and let's say it was the 20<sup>th</sup> batch of the day, then the code would be 0704120020.

You raise the question of expiration date for the product. As VitaPro is a non-perishable product, Agriculture Canada does not require an expiration date on the product, instead they have us use a "best before date". "Best before date" means that the product is at it's ideal state for consumption before a given date, but does not at all mean that the product is not consumable after that date. In fact the VitaPro products 333160 and 333161 have been tested many years after the best before dates with excellent results, as long as the seal is not broken on the pails. The best before date for the products which we are discussing, the products produced January 2, 2007 is August, 2008.

I hope that this answers all your questions, and as always I am available should you require anything further.
